The meeting was held at the junior/senior high school building and called to order by Board President Keith Kraus at 7:00 PM. The Pledge of Allegiance was done.

Mrs. Morgan, District Clerk, announced that the annual meeting notice, minutes of the May 8, 2019 budget hearing, and the 2019-2020 tax collectors' report were available.

Mrs. Morgan introduced Interim Business Administrator, Gay Fairbrother, who presented information on the proposed 2020-2021 budget.

The proposed budget proposition is as follows:

RESOLVED: That the Board of Education of the Jasper-Troupsburg Central School District, Steuben County, be and hereby is authorized to spend the sum set forth in the total amount of \$12,602,751 during the 2020-2021 school year and to levy the necessary tax, therefore.

The proposed bus lease proposition is as follows:

RESOLVED: That the Board of Education of the Jasper-Troupsburg Central School District is hereby authorized to lease and purchase and expend an amount not to exceed the estimated maximum cost of Four Hundred Fifty Thousand dollars, (\$450,000.00), including costs incidental thereto and the financing thereof, for a term not to exceed five (5) years, the following motor vehicles: Three (3)-66 passenger school buses, with funds from the 2014 and 2018 Capital Reserve Funds, the money being paid in multiple installments over the multi-year life of the agreements.

In addition, voters will be voting on one (1) school board seat for five (5) year term. One petition was returned and the ballot will have Andrew s. Butler as the candidate.
